GUIDELINES FOR EXPERIENCE REPORT ON WORK EXPERIENCEFOR ADMISSION TO THE CLASS OF MEMBER

- 1. Application for Class of Member Form SSESL 02
- 1.1 Rules for Professional Review Refer note 2 of the Application

2. Guidelines for preparation of report on work experience

- 2.1 A candidate is required to submit along with his application, a Report on his work experience related to the field of Structural Engineering.
- 2.2 Main objective of this report is to demonstrate that the candidate has achieved the degree of professional competence in the field of structural engineering required of a Corporate Member of the Society and has exercised responsibility at an acceptable level.
- 2.3 The report written in the first person and be concise. The report which should be printed/ typewritten on A4 size paper with double spacing. The report should not be less than 1500 words and limit to a maximum of 3000 words.
- 2.4 The candidate shall at the beginning of this report set out in chronological order particulars relevant to his past work experience.
- 2.5 This report should indicate to what extend the candidate has had insight into the structural design process and his familiarity with and use of relevant design codes.
- 2.6 The candidate must also include in his report an Organizational chart of his workplace, indicating his position within the organization. The chart should be certified by his Proposer and Seconder.

3. Interview

- 3.1 An interview by panel of Corporate Members of the Society will be conducted to assess the candidate's suitability for admission as a Corporate Member of the society.
- 3.2 The interview shall be conducted in the English language and the panel will also assess his ability to communicate verbally.
- 3.3 The interview will be based on the work experience report submitted by the candidate and he will be questioned on aspects of the structural design work carried out by him and the assimilation by the candidate of the requisite knowledge.
- 3.4 The candidate shall bring all necessary documentary evidences (drawings, design reports, ketches & etc.) along with him.
